Through a commitment to shared data, collaboration, and ongoing communication, Children's Optimal Health (COH) uses visual images and tools to inform policy, improve operations, promote research, and mobilize the community to better the lives of our children and youth. In 2015, COH completed one school year of mapping of student obesity and cardiovascular health data for Austin, Pflugerville, and Round Rock ISD's. We hosted a mini-summit with Pflugerville ISD to present results of our mapping to their Student Health Advisory Council (SHAC) and to staff, and we presented the Round Rock ISD mapping project at the Williamson County and Cities Health District (WCCHD) conference in September 2015. Along with Travis County Youth Substance Abuse Prevention Coalition (YSAPC) we held the third successful Behavioral Health community summit in November with over 100 attendees, which was successful at strengthening the network of providers. Youth substance abuse data and mapping from COH was used for strategic planning in the 2015 Travis County Mental Health Plan and the 2015 Travis County Substance Use Disorder Plan. COH continued assessment mapping for the Go Austin/Vamos Austin (GAVA) initiative in year three of analysis for 78744 (Dove Springs) and in year one for 78745. We coordinated with DCMC researchers to prepare for mapping of child maltreatment and a community summit for 2016. Projects on Flu Immunization and Asthma were begun. Existing maps from multiple projects overlaid with Austin City Council districts were provided to the new mayor and new city council members. COH completed updates to processes and contracts to remain in compliance with Federal data protections outlined in HIPAA HITECH and FERPA updates as well as completing a HIPAA Risk Assessment. The organization continued its involvement with the Urban Institute's National Neighborhood Indicators Partnership (NNIP), the Community Advancement Network (CAN) advisory committee, the City of Austin DSRIP Advisory Group, and the Travis County Youth Substance Abuse Prevention Coalition (YSAPC).
